Structure, Governance and Management

Governing Document

'The Church is governed in spiritual and temporal affairs by a Kirk Session under the Church of Scotland's Unitary Constitution.

Recruitment and Appointment of Trustees

The Elders are the Charity Trustees, and have responsibility for the administration of congregational finances, property, mission and outreach, safeguarding and other matters. The Kirk Session consists of the Minister and 'the ruling Elders'. The Kirk Session shall determine the number of Elders required for the oversight of the congregation, and the time when a new election is to take place. The Minister is called by the congregation and is ordained (if not the case already) and inducted by the local Presbytery, and is directly accountable to it for the discharge of the duties of his or her office. The Minister is the Moderator of the Kirk Session. In a vacancy, Presbytery appoints an Interim Moderator who is the Moderator of the Kirk Session. Elders are ordained for life and hold office till they cease to be members of the congregation, or their resignation is accepted, or they are deposed or otherwise removed from office

Organisational Structure

The Kirk Session is chaired by the Minister (or Interim Moderator) and has been meeting monthly (virtually by Zoom until August and since then in person). The Kirk Session presently has various sub-committees including Youth, Mission and Outreach, Finance, Property, and Visioning, which meet monthly as required to investigate issues relating to their respective remits, and to produce a report for approval at the full Court. The Treasurer has power to make small routine payments without reference to the Court.

Objectives and Activities

The Church of Scotland is Trinitarian in doctrine, Reformed in tradition and Presbyterian in polity. It exists to glorify God and to work for the advancement of Christ's Kingdom throughout the world. As a National Church, it acknowledges a distinctive call and duty to bring the ordinances of religion to the people in every parish of Scotland through a territorial ministry. It co-operates with other churches in various ecumenical bodies in Scotland and beyond.

Park Church meets for worship on a Sunday morning in the Peter Memorial Building. There have been increasing attendances in person, but in addition many members join worship through live streaming or sound recordings. In addition, at this time, there is normally a Junior Church, which is open to all the young people of the area, and a crèche facility is available for parents with young children. The church continued its schools programme supporting and hosting "Bubblegum and Fluff" sessions before Christmas, "Easter Code" in March and "Popcorn & Cake " to mark Pentecost for up to 120 senior primary school children in partnership with three local schools in 2022. The congregation continued a series of initiatives to encourage and support both young families and children, older and vulnerable members of the extended Church family.

In addition to its Sunday activities the church also normally hosts various groups during the week including Scouts, Ladies Group, various choirs, arts groups, Coffee Club and Friendship Lunches and provides a base for Stirling Street Pastors.

Achievements and Performance

Park Church provides spiritual and religious care to its 417 communicant members, and others living in its parish and in the wider area of the City of Stirling. Membership fell largely due to deaths and moves away.

The main service of worship on a Sunday had an average attendance of 100-110. On Christmas two services with almost maximum attendances took place. At Christmas, extra services were held and the early evening service attracted around 250 people. There is fellowship over tea and coffee in the Hall enjoyed by the majority of attendees after all these services. Monthly services are also held in a care home for the elderly (Annfield House) which are well supported and appreciated by residents. Residents in this this and other care homes and sheltered housing as well as several housebound members continue to be supported by regular calls, prayer letters, recordings of services and delivery of various small gifts. The church website provides updates on upcoming events and regular activities. Quarterly newsletters are delivered to all members. We also host a series of Bible Studies shared with neighbouring City Centre parishes. There have also been a number of more informal midweek evening services in the Hall.

During the year to 31 December 2022, one baptism, one wedding and 17 funerals were conducted.

A weekly pre-school children's play group called "SPARKS" run by church volunteers in the church halls continues to flourish. It has been very well received by up to two dozen children and their families. It has been a privilege and joy to see them grow and thrive as they learn to play with their peers. Existing restricted funds were used to purchase new equipment and storage facilities.

Park Church also hosted a monthly Cosy Café in winter months. The congregation actively supports Start-Up Stirling, an emergency foodbank run by the Salvation Army, Woman's Aid at Christmas, Christian Aid, Water Aid, the Church of Scotland Crossreach and HIV programmes, and overseas work in Nepal throughout the year.

Our buildings are used regularly by Park Church Ladies Group and Men's Badminton Club, Stirling Street Pastors, the 4th/6th Stirling Scout Group, Stirling City Choir, Torbrex Community Choir, Stagecoach (theatre workshop skills), Stirling Chess Club, Stirling Floral Art, Bereavement and counselling groups. The Church hosts a number of charitable concerts throughout the year. We also showed visitors around as part of Stirling Doors Open Programme.

The congregation has been blessed by the ministry of Rev Attie Van Wyk who was inducted to the charge on 27th January 2022. He has attracted many new people through his preaching and teaching, has been assiduous in pastoral care and has been a great encouragement to office bearers, members and all those with whom he encounters. The Presbytery Mission Plan involves increasingly close partnership working with neighbouring congregations of St Ninian's Old and with Holy Rude linked with Viewfield Erskine Churches and we look forward to working closer with them. In summary, the congregation is in good heart and looking forward in faith to new challenges in sharing God's Love with our Community.

Financial Review

The Trustees have prepared accounts on an accruals basis consistent with the previous year, to facilitate meaningful comparisons with that first full year of the newly united congregation when total income including proceeds from the sale of the former Allan Park South Church building last year exceeded £250,000. We owe huge thanks to Dr Brian Walker (convenor) and Mrs Catherine Jones (Treasurer) for their tireless work on behalf of the Finance Committee, as well as to our Independent Examiner, Mr Alan Skilling, C.A., and to our Church administrator Mrs. Sheena Tait.

Funds held in local bank accounts rose by £53,732, largely due to a bequest of £20,000, the transfer of £29,000 to our bank from the funds held by the General Trustees on our behalf following the sale of the former Allan Park South Church building, and receipt of tax refunds in respect of Gift Aid donations for both 2020 and 2021, in 2022. On an accruals basis there was a small deficit of £2062 for the year 2022 (2021 - £534 excess). The main ordinary source of income for the year continued to be from voluntary giving from members, and held up well. Income from rent of premises was more as the former manse in Laurelhill Place was rented again after renovation and organisations using the halls returned (together with some new users) after the lockdown.

We continue to benefit from a huge investment of time and talents from dozens of volunteers. Expenditure in 2022 was steady despite the increased missional activity. Although significant fabric expenditure, greater utilities costs and an increase in contributions to central church Giving for Growth Funds (previously called Ministries and Mission Fund) are anticipated, the trustees are confident that Park Church will be able to expand its charitable activities on a sound financial basis. This is a reflection of the continuing generosity of its members.

Reserves Policy

The Trustees' policy is to hold sufficient unrestricted reserves to meet the ongoing requirements and maintenance of the church and would wish to hold a minimum figure of £40,000 (actual £48,025). The bank account and deposit balances at 31 December 2022 were £258,428 (2021 - £73,693) which includes £521 (2021 - £521) in the Church of Scotland Investors Trust Deposit Fund, and a further £130,000 (2021 - nil) in the Church of Scotland General Trustees Restricted Fund for fabric purposes. In 2021 the Church of Scotland General Trustees held £159,395 on our behalf, which was received during the year and partly reinvested in the Church of Scotland General Trustees Restricted Fund. Going forward, restricted funds have been rationalised whilst ensuring their use is reserved for the designated purposes.

Risk Management

Trustees have assessed the major risks to which the church is exposed, in particular those related to operations and finance, and are satisfied that systems are in place to mitigate exposure to major risks. Our broad base of donors and our participation in National Stewardship Campaigns mitigate our exposure to financial risk.

Our staff and buildings are also risk managed through our Health and Safety policies.

Statement of Trustees' Responsibilities

Charity law requires the Trustees to prepare financial statements for each financial year which show a true and fair view of the state of affairs of the charity and its financial activities for that period. In preparing those financial statements, the trustees are required to:

- select suitable accounting policies and then apply them consistently;
- make judgments and estimates that are reasonable and prudent;
- state whether applicable accounting standards and statements of recommended practice have been followed, subject to any departures disclosed and explained in the financial statements; and
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charity will continue in operational existence.

The Trustees are responsible for keeping proper accounting records, which disclose with reasonable accuracy at any time the financial position of the charity and enable them to ensure that the financial statements comply with the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006. They are also responsible for safeguarding the assets of the charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

Report of the Independent Examiner

I report on the accounts for the year ended 31 December 2022 set out on pages 10 to 15.

Respective responsibilities of Trustees and Examiner

The charity's Trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006. The charity's Trustees consider that the audit requirement of Regulation 10(1)(d) of the Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under Section 44(1)(c) of the Act and to state whether particular matters have come to my attention.

Basis of the independent examiner's report

My examination was carried out in accordance with Regulation 11 of the Charities Accounts (Scotland) Regulations 2006. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeking explanations from you as Trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.

Notes on Balance Sheet

Tangible fixed assets

All tangible fixed assets costing in excess of £2500 having a value to the charity greater than one year, other than those acquired for specific purposes, are capitalised at cost. Depreciation is provided on a straight line basis to write off the cost, or initial value, of tangible fixed assets over their estimated useful lives:

Fixtures, fittings and office equipment 5 years.

Currently the charity has no assets in this category.

Buildings

Peter Memorial Church and halls – these are heritage assets and are not included on they balance sheet as information on their cost or valuation is not available. Insurance reinstatement value is £17,731,076 Manse (b) (acquired in 2021) is included at cost, and former manse (a) (now let out) is included at valuation less 10% levy due to General Trustees on disposal.

The Trustees consider that Buildings assets will, at worst, maintain their present values over time, so

that their estimated residual values will be no less than current valuations. Thus no depreciation is being provided on these assets.

Investments

Church of Scotland Investments (c) are included at cost. The values at 31.12.2022 were: Deposit Account £8532 (2021 - £9180) and Restricted Fund £125,804 (2021 - n/a)
